Treasurer – No expenses to report for September. Total funds available \$14,301.59.

Public Relation Officer – Doc reported Cascade Meats appreciates the new business received from our members after our meat raffle. Doc stated Cascade Meats will provide another half beef for our 2023 raffle.

Doc also provided information to the chapter about the SCRIPS program through Kwik Trip to help our chapter to raise additional funds. He will follow up and provide further information.

Trooper reminded all members of the CVMA WI State officer elections coming up at the January State meeting. Positions up for election are the State Representative, the State XO and the State Sergeant at Arms.

By Laws Committee – Chapter by-laws are completed.

Auxiliary shopping trip is scheduled for Saturday, November 5.

Trooper stated nominations are closed for the following positions:

Chapter XO – Keith "Creedence" Jenks has agreed to continue in this role. No other nominations were received.
